Touch Pad Controls

Touch Pad Gas Heaters

These heaters have a pilot light safety system that turns the heater off if not enough fresh air is available. Do not tamper with this safety system. If the heater shuts off, do not re-light until you provide fresh air. If the heater keeps shutting off, have it serviced. Keep the burner and control compartment clean.

Carbon monoxide poisoning may lead to death. Early signs of carbon monoxide poisoning resemble the flu, with headache, dizziness, and/or nausea. If you have these signs, the heater
